Forms of certificaction of applicants of higher education	Certification of a graduate of the educational program of the specialty 014 Secondary education (Language and literature (English)) is carried out in the form of a qualifying exam in English and a complex qualifying exam in German/French language and world literature, and ends with the issuance of a document of the established model awarding him with a bachelor's degree with qualification: Bachelor of Education, teacher of English, second foreign language (German/French) and world literature.
Requirements for qualification exams	The qualification exam in English is conducted in written form. Tasks include questions from theoretical and practical disciplines and stylistic analysis of the text. The grade for the exam is the sum of the points for the answers to each of the tasks. The comprehensive qualification exam in a second foreign language and foreign literature is aimed at verifying the achievement of the learning outcomes defined by the educational program, and involves the students completing test tasks in foreign literature and a second foreign language (German/French) on the LMS platform Moodle of the university, as well as an oral answer (tasks to the text and communication on a conversational topic). The grade for the exam is the sum of the points for the answers to each of the tasks.
