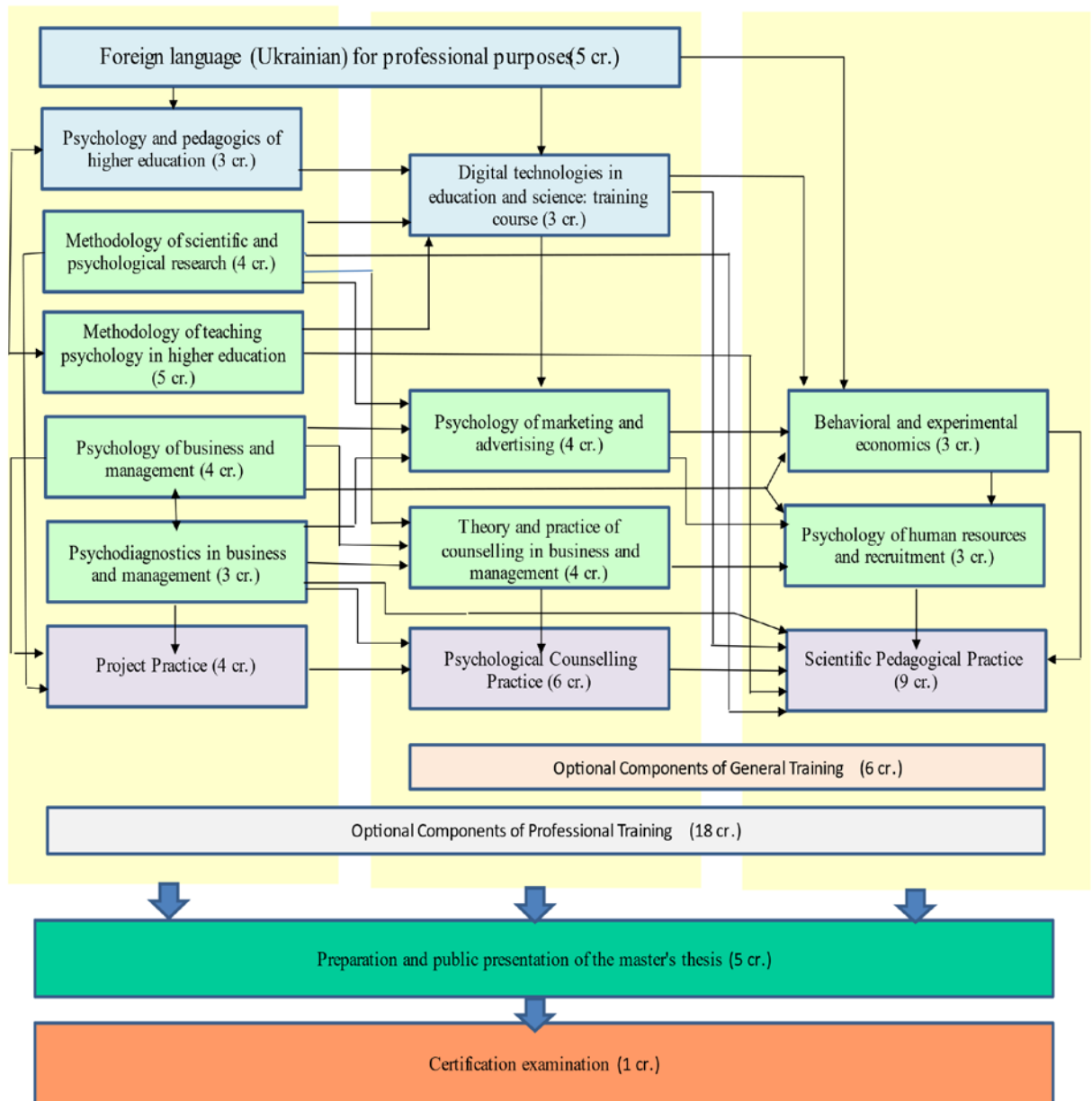

According to the Law of Ukraine "On Higher Education", students have the right to "choose academic disciplines within the limits provided by the educational programme in the amount of not less than 25% of the total number of ECTS credits. At the same time, students have the right to choose academic disciplines offered for other levels of higher education, in agreement with the head of the relevant faculty or department."

Higher education institutions independently determine the mechanisms for exercising the right of students to choose academic disciplines.

It is recommended to use both block forms of choice and completely free choice of disciplines by students.
