



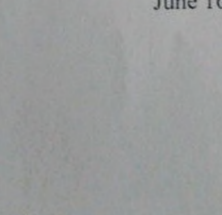

Fundamental training in various fields of linguistics, literary studies and methods of teaching foreign languages and cultures enables graduates to effectively perform innovative tasks in their further independent creative and teaching activities. This is ensured through the consistent study of integrated compulsory and elective components of general and professional training aimed at developing a certain system of professional knowledge (hard skills) and social and psychological skills (soft skills) necessary for prompt response to market requirements. A comprehensive status that allows a master's degree holder to possess competencies of wide application in the field of education. Applicants for higher education in this educational program have the opportunity to participate in the international academic mobility program, which is implemented in German, English, Polish and requires the necessary level of language competence (Poland, Czestochowa, Higher School of Linguistics). <p>Forms of certification of higher education candidates</p>	<p>The certification of graduates of the educational program is conducted in the form of a complex qualifying examination in the second foreign language and a public defense of a master's thesis and ends with the issuance of a standardized document on the award of a master's degree with the award of a qualification: Master of Secondary Education. Teacher in English and German/French Languages and World Literature.</p> <p>A prerequisite for admission to the defense of a master's thesis is the successful completion of the applicant's individual curriculum.</p>
<p>Requirements for the master's thesis</p>	<p>The master's thesis is aimed at solving a specialized problem and/or practical problem in the field of methods of teaching foreign languages/ philology (according to specialization), which involves research and/or innovation and is characterized by uncertainty of conditions and requirements. The paper should demonstrate the level of mastery of pedagogical/philological research methods and skills of creative problem solving. The defense of the thesis involves identifying the applicant's ability to analyze scientific sources, reasonably present the results of their research, as well as the level of their readiness for independent practical work. The master's thesis must not contain academic plagiarism, fabrication and/or falsification.</p> <p>The thesis must be checked for plagiarism on the educational platform of TNPU Moodle.</p> <p>The master's thesis is published on the official website of TNPU or stored in the TNPU repository.</p> <p>More detailed requirements for qualification work (in particular, for the selection and approval of the topic, structure and scope, evaluation criteria, etc.) are developed and formulated in the relevant regulations by the specialized department, based on the specifics of the educational program "Secondary education (English language and literature)" and the curriculum for the training of applicants for the second (master's) level of higher education in the field of education in the specialty 014. Secondary education.</p>
<p>Requirements for public defense</p>	<p>The master's thesis defense takes place in public at a meeting of the examination committee. A prerequisite for admission to the defense of the master's thesis is its preliminary defense at a scientific and methodological seminar, testing of research results and main conclusions at scientific conferences, methodological seminars, etc. It is advisable to publish abstracts, articles in the student's and master's scientific journals of TNPU, in domestic and foreign professional scientific journals.</p>
<p>Requirements for the certification/complex qualifying exam</p>	<p>Complex qualifying exam in the second foreign language (German/French) and world literature is aimed at verifying the achievement of learning outcomes defined by the educational program.</p> <p>The Complex qualifying exam in the second foreign language (German/French) and world literature consists of two tasks: the first is reading, translating and commenting on a fragment of an unfamiliar text, and the second is oral communication in accordance with a proposed communicative situation within the specified conversational topic.</p> <p>The grade for the exam is the arithmetic mean of the sum of the scores for both tasks. If the student's answer to one of the tasks is graded "unsatisfactory", the entire exam is graded "unsatisfactory".</p>

The certification is carried out openly and publicly.






